5) Requires that referrals to tobacco cessation resources be provided to students and staff						
6) Requires enforcement for <ul style="list-style-type: none"> • Student Violations

III. Additional Policy Elements						
1) Provides rationale for tobacco-Free School Policy						
2) Prohibits tobacco use by visitors at school functions away from school property						
3) Prohibits possession of tobacco by students in school buildings, on grounds and at school-sponsored events						
4) School will request tobacco-free editions of publications in school libraries						
5) Prohibits students from wearing or displaying tobacco-related clothing, gear or other paraphernalia						
6) Prohibits tobacco industry sponsorship and marketing (e.g., no gifts, funding or parent/classroom educational materials from the tobacco industry)						
7) Requires Alternative to suspension educational program to be incorporated into Enforcement Procedures for students who violate policy						
8) Requires that the policy be communicated annually to:
